First of all, I must apologize for the delay in creating the current Newsletter. However, there were several reasons for this, including my recent move and lack of content. The website has likewise been slow in developing.

1) The following was contributed by Rosalie Perrin and was extracted from the newspaper:

Hantsport Advance (from Hantsport, Hants County, Nova Scotia) of April 7, 1909

BORN

NEWCOMB - At Hantsport on Sunday March 8th, to Mr. and Mrs. J. H. Newcomb, a daughter. DODGE - At Kempt Shore, March 28th, 1909, to Mr. and Mrs. Lawson H. Dodge, a daughter. O'BRIEN - At Noel, Hants Co. March 17th, to Mr. and Mrs. Martin O'Brien, a son. DONALDSON - At Lower Stewiacke, March 25th, to Mr. and Mrs. Thomas H. Donaldson, a daughter.

DIED

MCEACHERN - At South Uniacke, March 27th, Daniel McEachern, aged 53 years. CURRY - At Windsor, April 1, Ethel May, daughter of Mr. and Mrs. Timothy Curry, aged 2 years and 3 months.

*** BENEDICT - At Highfield, Hants Co., March 27th 1909, Rachael Benedict, widow of the late Henry Benedict, aged 80 years. ***

MAXNER - At Windsor, March 28th, Hedley, son of John T. Maxner, of tuberculosis, aged 31 years.

2) DNA Testing Results - descendant of John Handover Stillman

DNA test results came back for the descendant of John Handover Stillman, b. c. 1802, Nova Scotia. You may recall that John H. Stillman bought and sold land in Parrsboro Township in 1827 and 1832 respectively. He moved to Richmond Parish, Carleton County, New Brunswick and had many land transactions there (see Newsletters 3 and 4 for transcriptions of the New Brunswick Land records). By 18 March 1866, he had moved to Eau Claire, Wisconsin, being approximately 64 years old.

The DNA high resolution test results indicate that his descendant's DNA is a perfect match for the Dillman family's ancestor, Hans George Dillman. This DNA profile is extremely rare and this test result further supports the hypothesis that Hans George Dillman is the father of our George Stillman and that George Stillman is the father of John Handover Stillman.

It should be noted that there is one difference out of 37 "markers" when comparing John Handover Stillman's DNA to the DNA profile for George Henry Stillman. However, differences in DNA markers do occur at RANDOM every now and again which is why these tests are useful to distinguish between different branches of family trees. If there were no periodic RANDOM differences, every male on the planet would carry the same DNA profile, making DNA studies useless for genealogy.

As a result of this round of test results, I have put together an updated discussion for the Dillman DNA Project. If anyone wishes to have a copy, please e-mail me.

3) New DNA participant.

A descendant of David Thomas Stillman, b.ca. 1808 in Nappan, Nova Scotia has provided a DNA sample to be tested. Results are still pending.

David is candidate to be considered a son of George Stillman. He moved to Botsford Parish, Westmorland County, New Brunswick, married and raised a family there. It will be very interesting to see how these results turn out.

<u>December 1, 1878</u>, Newport, By license, Methodist, by Rev. Chas. Brellte - Harris H. Foley, 45, Widower, carpenter, of and born in Belmont, and Arabel Parker, 23, Spinster, of and born Walton. Only the name of Harris Foley's father is given - also Harris H. Foley, farmer. Arabel's parents were Ananias and Harriet Parker. (Note: These are the same parents for Rebecca Annie Parker, b. abt 1842 in Walton, who married Levi Stillman. Thus, Arabel and Rebecca Annie were sisters). The witnesses to Arabel's marriage were Sarah Brellte and Sarah Campbell.

Same Source, but p. 154, #76:

<u>September 1, 1882,</u> Belmont, By license, Methodist, by Rev. Robt. McArthur Charles A. Foley, 24, Bachelor, Carpenter, of and born in Belmont, and Susannah Benedict, 17, Spinster, of and born in Belmont. Charles Foley's parents were Harris Foley and Sarah. Susannah Benedict's parents were James Benedict and Rachel (Stillman). Witnesses: W. H. Knowles and Lucinda Foley.

Same Source, but p. 41, #61:

<u>August 13, 1870,</u> Walton, by License, Baptist Church, by Rev. Jeremiah Bancroft Levi H. Stilman, 27, Bachelor, Farmer, of and born Newport, and Annie Parker, 28, Spinster, of and born Walton. Groom's parents: George & Jane Stilman. Bride's parents: Ananias & Harriet Parker. Witnesses: Augusta M. Bancroft and Clarence Bancroft.

Same Source, but p. 65, #48:

April 2, 1873, Newport, By License, Wesleyan Church, by Rev. J. McMurray Francis Stillman, 24, Bachelor, Farmer, of and born Newport, and Eliza McDonald, 29, Widow, of Walton. Groom's parents: Geo. & Jane Stillman. Bride's parents: Jas. & Mary Scott. Witnesses: Henry Benedict and Leonard Benedict.

5) The following was brought to my attention by Rosalie Perrin:

The Moss Diary CD, which is available from the Springhill Historical Society, has roughly 7 mentions of Stillmans. According to the Springhill Historical Society website, "In 1918 Joseph Moss began to keep a record of deaths in Springhill, Nova Scotia. He included most deaths that occurred in the town as well as the names and death dates of many native Springhillers who died elsewhere."

6) Muster Rolls from the British Army during the American Revolutionary War

I have recently visited the National Archives in London, UK and have looked through their collection of 25 Muster Rolls for the 2nd Battalion of the 84th Regiment, where George Stillman served during the American Revolutionary War.

2 of the Muster Rolls I found listed George Stillman among the Privates. Among the 25 Muster Rolls there, none mentioned George Dillman. I understand from Col. Kim Stacy, who is a dedicated researcher of the 84th Regiment, that many papers were lost in a house fire where Lieutenant Colonel John Small, the 84th Regiment's Commander-in-Chief, resided in Nova Scotia. As I don't currently have access to a scanner, I have transcribed the 2 documents and they appear on the following pages. When I can get them scanned, I will place them on the website.

I am also including a listing of the other Muster Rolls held at the National Archives, for completeness.

Muster Rolls

Based on looking at 25 different Muster Rolls, the following are an explanation of some abbreviations:

Do – Ditto (standard)
S. River – Spanish River
F. Edward – Fort Edward
NFLand – Newfoundland
C – Command
Regt – Regiment
Octr – October
Decr – December

It should be noted that the men appearing in the Tenth Company under Captain Alexander Murray for the 6 months of 25th June 1782 until 24th December 1782 reappear in Captain Murdoch McLean's Company from the 25th December 1782 until mustering out on 10th October 1783. The differences are primarily in spelling of surnames. Some of the men transferred out/in, but predominantly, it is the same group.

I did not find any mention of any Dillman. The Muster Rolls covered the period 1779 until the end of the war in 1783. There were an additional 3 Muster Rolls from 1794, 1795, and 1796 when the Regiment was reformed in England later on. These 3 are not included in the 25.


